Kim Turner and Dick Dawson, Co-Chairs of this sub-committee have recently updated the Risk Dictionary resulting in many new areas of Risk which they believe more closely correspond to the way most colleges and universities are structured. The recent update of the Risk Dictionary was largely influenced by The University of Texas System's Risk Assessment Taxonomy, and we appreciate their assistance in this important refresh effort.

As you might imagine, keeping this massive database current and up-to-date is more than two people can handle. Consequently, we are asking for individuals to volunteer to take ownership of one (or more) of the major categories listed below and be a member of this committee.

- Working with the Sub-committee chairs and other members of the committee to discuss ways to improve the Risk Dictionary.
- Reporting the status of your assigned areas to the sub-committee Chairs during periodic conference calls.

If you have ever wanted to contribute to ACUA, but did not feel that you could afford the time, this is a way to give back. It should not require much of your time since it should already be closely tied to the work you are doing on a daily basis.
