




What is Agile?





Focus on value | Go small | Limit WIP | Deliver iteratively | Gather and act on feedback



The Agile Manifesto outlines the 12 key principles that guide agile today:

Satisfy the Customer	Welcome Change	Deliver Work Frequently	Work as a Team	Work with a Motivated Team	Use Face-To-Face Conversations
Our highest priority is to satisfy the customer through early and continuous delivery of valuable products and services.	Welcome changing requirements at all stages in the process. Agile harnesses change for the customer's competitive advantage.	Deliver products and services frequently for a quick turnaround time.	All key stakeholders must work together daily throughout the project.	Deliver products and services around motivated individuals. Give them the environment and support they need and trust them to get the job done.	Efficient and effective method of conveying information to and within the team is through face-to-face conversations.
Measure of Progress	Maintain a Constant Pace	Focus on Technical Excellence	Keep It Simple	Self-Organizing Teams	Reflect and Adjust
Valued and impactful audits are the primary measure of progress.	Agile processes promote sustainable development. The stakeholders should be able to maintain a constant pace indefinitely.	Continuous attention to technical excellence and good customer service enhances agility.	Simplicity—the art of maximizing the amount of work not done—is essential.	The best architectures, requirements, and quality of work emerge from self- organizing teams.	At regular intervals, the team reflects on how to become more effective, then tunes and adjusts its behavior accordingly.







% Teams globally using frameworks & methods. (One team might use > 1 method around the year) Source – 15th State of Agile Report






